## CONTINUATION OF ARTICLES OF INCORPORATION FOR ISLEY SQUARE HOMEOWNERS ASSOCIATION, INC.

ITEM 7.

PROVISIONS REGARDING THE DISTRIBUTION OF THE CORPORATION'S ASSETS UPON ITS DISSOLUTION.

Isley Square Homeowners Association, Inc. (the "Association"), formed pursuant to the provisions of a Declaration of Covenants, Conditions and Restrictions for Isley Square ("Declaration"), may be dissolved with the assent given in writing and signed by the Members entitled to cast not less than eighty percent (80%) of the votes of the Association; provided, however, the Association may not be dissolved during Declarant's Development Period (as defined in the Declaration) without Declarant's prior written consent. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which the Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to a non-profit corporation, association, trust or other organization to be devoted to such similar purposes.

#### CONFLICT

In the event of any conflict between these Articles and the Declaration, the provisions of the Declaration shall control.
