## **Pond Life**



As we begin a brand-new year, I wanted to call your attention to one of our most cherished features: the pond. Located behind the swimming pool, it's an ideal place to unwind and appreciate nature's beauty by observing the ducks, watching the blue herons that walk the shoreline, spotting the occasional deer or rabbit, or simply spending a quiet afternoon fishing. The

pond offers a delight to many. And not to be forgotten, is our very own resident Muscovy duck, known to some as Buddy and to others as Kenny, but to most people, his name is Clarence.

#### It's All Connected

Did you know that the pond is fed by the storm drains along the streets in our neighborhood? These keep our community safe from flooding by diverting extra rainwater and snowmelt away



from streets and buildings and directly into the pond through a network of pipes. During a hard rain, the water running down the gullies and into the drain includes natural things like leaves, dirt, and leaves, and unnatural things like plastic wrappers, plastic bottles, chemicals, and gas and oil residue from the pavement. Anything dumped on the street or in the gutters ends up in the pond.

#### A Ducks Life--Interrupted

During the freeze, Clarence could not get in the water until the ice melted. Although he is fed by his special person, he still needs to get to and in the water. As the weather warmed, the ice melted, and I got to see him bathing for the first time in several days. He dunked himself in the water and vigorously ruffled his feathers many times. Then, he spread his big wings and skittered across the smooth water, almost as if he was walking on it. The next day, the pond was covered in a film of gas and oil so thick that it coated my finger. pushed the pollution to the west end, relegating wildlife to the other. Clarence's neck ruffles were stained an odd color from swimming through the polluted water. This was not the first time the pond has been polluted. A substance probably used in home construction or renovation was dumped or leaked into a storm drain. This ended up in the pond creating a smelly scum that took three weeks to go away.

This year, fertilizer runoff from grass areas has

contributed to algae blooms in the pond as well as a scummy smell. DO NOT apply fertilizer or herbicide within 10 feet of the pond, and tell your landscapers not to do so, too.



#### Keep It Clean

The functionality and cleanliness of our storm drains, streets, and our community have to be maintained. This means taking precautions to keep the water, as well as the air and soil as safe as we can. We can build a better future for us all by fighting the contamination of our water. The actions of one of us affect all of us!

#### **Handy Tips**

- 1. Do not clean chemicals from equipment on the street or use the storm drains to get rid of oil, chemicals, and soapy water.
- If you spill gas or oil on your driveway or street, use cat litter, sand, cornmeal, or commercially-available substances to soak up the liquids. Then sweep the debris into a bag and take it to the hazardous materials collection site listed below.
- 3. Throw bottles and trash into trash cans not in the pond.
- 4. Ensure trash from overflowing garbage cans are not left in the street.
- 5. Clean up after yourself. Carry your trash with you until you are able to put it into a trash can.

# Don't Feed the Ducks and Geese: It's Bad for Them and Bad for Our Pond

We all love to watch the ducks on our pond (see Leslie's article on page 1), but if you feed the ducks, you are hurting them. Feeding them can make the ducks and geese sick and could even kill them. It causes overpopulation, can make them more dependent on us, and lead to aggressive behaviors, according to Chris DePerno, assistant professor in fisheries and wildlife sciences at N.C. State's Department of Forestry and Environmental Resources.

Waterfowl who are fed by humans are often found to suffer from poor nutrition. Many of the items commonly used to feed waterfowl, including cracked



corn, are low in protein and are very poor substitutes for natural foods. Ducks can feed themselves!

At the end of last summer we had 24 Mallard ducks on the pond. Too many ducks leads to too much poop and can result in water pollution that leads to summer algae blooms. We had several algae blooms in the pond this last summer.



<u>If everyone stops feeding ducks and geese, they won't disappear</u>. We don't need to feed them in order to enjoy them. In fact, it should be apparent now that the **best thing you can do for the ducks is to stop feeding them**.
