NORTH CAROLINA GUILFORD COUNTY AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR FRIENDLY ACRES TOWNHOMES

THIS AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR FRIENDLY ACRES TOWNHOMES (the "Declaration") is made this the 2 day of 100 day of 2012, by the Friendly Acres Townhomes Homeowners Association, Inc., (the "Association").

WITNESSETH THAT

WHEREAS the following instrument was recorded in the Guilford County Registry by the Declarant, Starmount Residential, Inc., and subjected Friendly Acres Townhomes (the "Property") to the following Declaration of Covenants, Conditions and Restrictions to the same:

(a) Book 6177, Page 2823 on September 28, 2004.

WHEREAS, the Declaration applies to and runs with the land described Plat Book 156, Page 12 of the Guilford County Register of Deeds.

WHEREAS, Article XI, Section 3 of the Declaration provides that the Declaration may be amended with the consent of sixty-seven percent (67%) of the votes of the Association; and such vote and approval has been obtained. The instrument containing said signatures may be found among the books and records of the Association. The Officers of the Association executing this Amendment have certified that the requisite Owner approval has been obtained; said Certification can be found attached hereto as Exhibit A.

NOW THEREFORE, the Declaration of Covenants, Conditions, and Restrictions for Friendly Acres Townhomes shall be amended as follows:

The following shall be added to Article VI (Maintenance), Section 2:

"SECTION 2. Maintenance. In the event the need for maintenance, repair and replacement caused by fire, lightning, wind, storm, hail, explosion, riot, riot attending a strike, civil commotion, aircrafts, vehicles and smoke, as the foregoing are defined and explained in the North Carolina Standard Fire and Extending Coverage Insurance Policies, the costs of such maintenance, replacement or repair shall be added to and become part of the assessments to which such Lot is subject."
