Rock Creek Community Association, Inc.

- 1. <u>Distribution of the Corporation's Assets upon Dissolution</u>. Upon dissolution of the corporation, all liabilities and obligations of the corporation shall be paid and discharged, or adequate provision shall be made therefor, and the remainder of the corporation's assets shall be distributed as required by the terms of N.C.G.S. Section 47F-2-118, as amended, of the North Carolina Planned Community Act.
- 2. <u>Limitation on Liability of Directors</u>. To the fullest extent permitted by the North Carolina Nonprofit Corporation Act, as the same exists or may hereafter be amended, no director of the corporation shall be personally liable to the corporation for monetary damages for breach of any duty as a director.
