## Storrington Homeowner's Association Pool Rules (Updated for Covid-19\*)

Summer 2020 Pool Schedule: Tuesday-Sunday 11am-6pm, closed every Monday for cleaning, July 1st-Labor Day^

**WHO** Our pool is for the exclusive enjoyment of permanent Storrington residents. Absolutely NO GUESTS (non-Storrington residents) will be permitted due to Covid capacity restrictions. All children under the age of 15 must be accompanied by a head-of-household and ID may be required to enter. The association reserves the right to deny entry to people from homes that are not current on their monthly dues. Renters may request use of the pool by having their landlord contact Prestige.

**HOW** Each visitor will be asked to complete new paperwork for each pool season. New wristbands will be issued only to those who have done so. This band is required to enter the pool for anyone 2 years of age and above. Visitors must sign in and out at each visit and have their temperature recorded. Anyone exhibiting symptoms of Covid-19 (or other communicable disease) or having an open wound or infection will not be permitted to enter.

**CAPACITY** The Pool Monitor has the authority to reduce the number of people in the pool at any time for any reason. The maximum pool deck capacity is 10 people. You may be asked to leave if you have been using the facility longer than 1 hour if others are waiting. Be prepared to be denied entry on your first attempt due to capacity restrictions.

**ATTIRE** Proper swim attire is required. Street clothes may NOT be worn in the pool. No street shoes (sneakers, boots, etc.) are permitted on the pool deck. Be prepared to remove street shoes prior to entering the gate. No bobby pins, hair pins or barrettes permitted in the pool.

**HYGIENE** Children who are not potty trained must wear a swim diaper (penalties may result for guardians of children causing pool closures). A shower on the pool deck is required before entering the pool. No Band-Aids, gum, glassware, or other breakables are permitted.

**DOs** Per social-distancing guidelines, pool visitors must stay at least 6 FEET AWAY from non-household members at all times. Enter restrooms one household at a time. Swim at your own risk. Remember, the Pool Monitor is NOT A LIFEGUARD. Enter the pool after 11am and before 6pm, on Tuesday-Sunday, and always in the presence of a Storrington pool monitor.

**DON'Ts** No smoking, animals or weapons of any type are permitted on the property at any time. No bicycles, skateboards, motorized vehicles, battery operated toys, etc. are permitted in the pool area (or tennis court). Absolutely no food, inflatables, pool toys, balls, or other items may be brought into the pool area. The only allowable item is a personal chair if desired. NO CHAIRS will be available on the pool deck to minimize the spread of germs. NO DIVING, spitting, running, dunking, foul language, or any form of roughhousing is permitted. Do not enter the main clubhouse for any reason. NO LOITERING is permitted. Unless you are actively playing tennis, Hopscotch, or swimming, you should not be on the Clubhouse property, even after hours (failure to comply may lead to prosecution for trespassing).

ALL STORRINGTON HOMEOWNERS SHALL USE THE POOL AND ITS FACILITIES AT THEIR OWN RISK. THE ASSOCIATION, ITS BOARD MEMBERS, PRESTIGE MANAGEMENT, NOR THE POOL MONITOR ON DUTY IS RESPONSIBLE FOR LOSS, THEFT, OR DAMAGE TO PERSONAL PROPERTY, CONTRACTED ILLNESS, INJURY OR DEATH.
